#### **Guidelines for the Participating Organisations**

- The companies participating will have to register online at https://cmib.icai.org/.
- The companies can access the database at https://cmib.icai.org/
- Participating companies will have to provide the list of shortlisted candidates online at https://cmib.icai.org/
- Final list of candidates appearing for interview will be available online at https://cmib.icai.org/
- Shortlisting of the candidates by the company is restricted to 10 times of the number of vacancies in that particular organization.
- Once a company has selected any candidate and the offer is accepted by the candidate it is the responsibility of the company to inform CMI&B.
- The companies participating have to offer a minimum CTC of INR 6 lakhs to the candidates in the Second Round of Campus.

- The timing for the Interviews will be from 9:00 A.M. to 6:00 P.M.
- Interviews will be conducted through virtual mode by the platform provided by the participating organization as per the roster prepared by them.


