Guidelines for the Participating Organisations

- The companies participating will have to register online at <https://cmib.icai.org/>.
- The companies can access the database at <https://cmib.icai.org/>
- Participating companies will have to provide the list of shortlisted candidates online at <https://cmib.icai.org/>
- Final list of candidates appearing for interview will be available online at <https://cmib.icai.org/>
- Shortlisting of the candidates by the company is restricted to 10 times of the number of vacancies in that organization.
- Once a company has selected any candidate and the offer is accepted by the candidate it is the responsibility of the company to inform CMI&B.

Infrastructure and other facilities

- The timing for the Virtual Interviews will be from 9:00 A.M. to 6:00 P.M.
- Interviews will be conducted through virtual mode by the platform provided by the participating organization as per the roster prepared by them.
- Link for attending virtual interview will be shared by participating organizations to all consented candidates at their registered e-mail id.
- CMI&B simply acts as a facilitator to bring the recruiter and NQCA's together.
- Roster for the interview must be prepared and shared with CMI&B by the participating organization at least one day prior to the interview and will be hosted on <https://cmib.icai.org/>.
