## **Second Round of Campus Placement Programme-**

**16<sup>th</sup> – 20<sup>th</sup> August, 2021**

Second Round Campus Placement Programme is a platform specifically designed and aims to provide placement opportunities to the Newly Qualified Chartered Accountants (NQCAs) who could not get job during our main Campus Placement Programme held in February-March, 2021 & April-May, 2021. This programme is an extended dimension to the existing initiative i.e. Campus Placement Programmes, undertaken by CMI&B to provide employment opportunities to the Newly Qualified Chartered Accountants, organized twice a year.

### **ELIGIBILITY OF CANDIDATES FOR SECOND ROUND OF CAMPUS**

NQCAs who could not get job during our main Campus Placement Programme held in February-March, 2021 & April-May, 2021.

- In case of not being selected during main campus placement programme (February-March, 2021 & April-May, 2021), but wish to participate, candidates have to register online at <https://cmib.icaai.org/>.
- NQCAs who have already been selected in bigger or smaller centre during our main Campus Placement Programme held in February-March, 2021 & April-May, 2021 and finally signed the declaration are not eligible to apply for second round of campus placement programme.

## **GUIDELINES FOR THE CANDIDATES**

- In the event of not being selected in bigger centre & smaller centre but wish to apply for second round of campus, you can do so through portal on 26<sup>th</sup> – 30<sup>th</sup> July, 2021 (up to 5:00 P.M.) The candidates have to register online at <https://cmib.icai.org/>.
- A Candidate can select only **three (3)** recruiting entity irrespective of the number of recruiting entities shortlisted them.
- Once finally selected by any company and accepting the offer by signing the offer letter, the candidate cannot appear for any other interview in second round of campus or accept job from the recruiting organisation that have interviewed him/her earlier.
- The last dates for filling up online application forms for the candidates, shortlisting details, consents for appearing in the interviews of the various participating organizations will be as per the details given at <https://cmib.icai.org/>.
- The Candidates have to apply online at <https://cmib.icai.org/> for the Programme under the head '**Second Round of Campus**'.
- The Submission of the form would be complete only after clicking the **Second round of Campus Tab** after filling the Registration Form".
- Candidates can choose only one centre.
- **There is no participation fee for the candidates.**
- Interviews will be conducted through virtual mode.
- The timing for the Interviews shall be from 9:00 A.M. to 6:00 P.M.
- Interviews will be conducted through virtual mode by the platform provided by the participating organization as per the roster prepared by CMI&B.
- Link for attending virtual interview will be shared by participating organisations to all consented candidates on their registered e-mail id.
- CMI&B simply acts as a facilitator to bring the recruiter and NQCA's together
- Roster for the interview will be shared by CMI&B with the participating organization at least one day prior to the interview and available on <https://cmib.icai.org/>.
