GUIDELINES FOR THE PARTICIPATING ORGANISATIONS

- The companies participating will have to register online at <https://cpabiplacements.icai.org/>.
- The participation fees (non-refundable) should be remitted at **ICAI, Head Office, New Delhi**, only.
- Access to the candidate database shall be allowed only after receipt of the participation fee by CMI&B Secretariat. Fee is chargeable even if a recruiting organisation withdraws after confirming the participation and data access has been given.
- The companies can access the database at <https://cpabiplacements.icai.org/>.
- Participating companies will have to provide the list of shortlisted candidates online on placement portal <https://cpabiplacements.icai.org/>.
- Final list of candidates appearing for interview will be available online at <https://cpabiplacements.icai.org/> one day after consent date by candidate at respective centres.
- Shortlisting of the candidates by the company is restricted to **7 times** of the number of vacancies in that particular organisation.
- Once a company has selected any candidate and the offer is accepted by the candidate it is the responsibility of the company to inform the centre heads.
- The companies participating have to offer **a minimum CTC of ₹ 11.00 lakhs** to the candidates in the Career Ascent Programme.
- Only one room will be provided to each company for conducting the interview process.
