- No restriction on the number of interviews a candidate can attend at selected centre.
- On final selection by any organisation, upon accepting the offer by signing the offer letter; the candidate cannot appear for any other interview/ accept any other job from any other recruiting organisations that have interviewed him/her earlier through this Overseas Campus Placement.
- To attend at their cost – travel, stay etc.
- ICAI/Participating organisations will not be responsible for selection/rejection of the candidates.

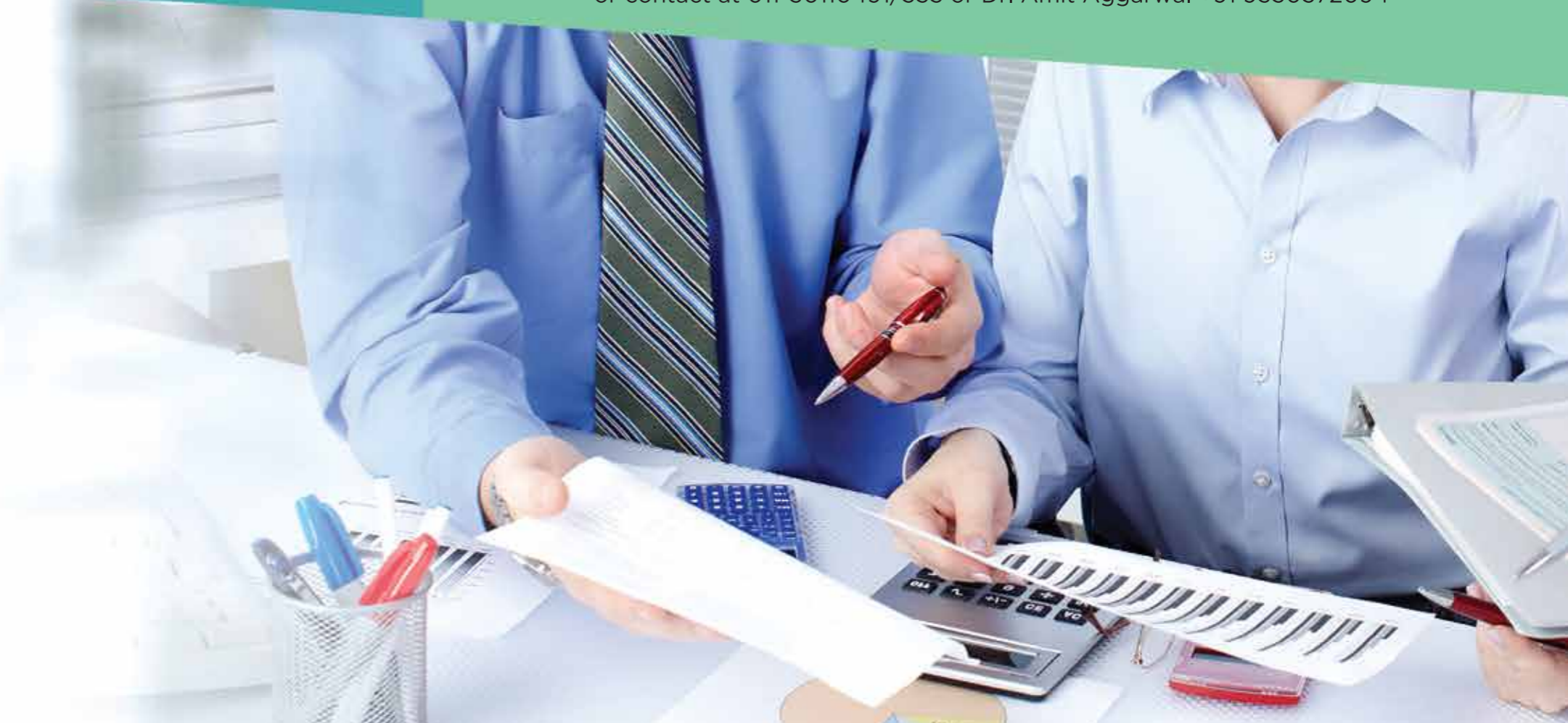

GUIDELINES FOR PARTICIPATING ORGANISATIONS

1. The organisations/ prospective employers intending to participate in the overseas campus placement programme of the ICAI will have to register online on <https://cpabiplacements.icai.org/> on or before **31st July 2018**.
2. List of candidates applied will be available online on <https://cpabiplacements.icai.org/>.
3. Participating organisation should notify to ICAI the number of vacancies, position, job description & likely remuneration and other benefits attached.
4. Short listing of candidates by individual recruiting organisations shall be restricted to maximum seven times of the number of vacancies in that particular position, which are expected to be filled up.
5. Selected candidates should be notified before the conclusion of the campus.
6. Once offer letter is issued and accepted by the candidate, it should not be withdrawn or modified without the consent of the ICAI.
7. ICAI shall not be involved in any litigation or dispute or loss/damage in connection with the campus interview
8. Once participation is confirmed, HR team should be present at the opted locations and the composition and their schedule should be notified to ICAI latest by **16th August 2018**.
9. The entire process above would be done online.
