- No Participation Fees for Second Round of Campus Placement Programme from participating Organisations.

Guidelines for the Participating Organisations

- The companies participating will have to register online at <https://cmib.icai.org/>.
- The companies can access the database at <https://cmib.icai.org/>
- Participating companies will have to provide the list of shortlisted candidates online at <https://cmib.icai.org/>
- Final list of candidates appearing for interview will be available online at <https://cmib.icai.org/>
- Shortlisting of the candidates by the company is restricted to 10 times of the number of vacancies in that particular organization.
- Once a company has selected any candidate and the offer is accepted by the candidate it is the responsibility of the company to inform CMI&B.
- The companies participating have to offer a minimum CTC of INR 5.5 lakhs to the candidates in the Second Round of Campus.

- Infrastructure and other facilities:
 - a) The timing for the Interviews shall be from 9:00 A.M. to 6:00 P.M.
 - b) Interviews will be conducted through virtual mode by the platform provided by the participating organization as per the roster prepared by CMI&B.
 - c) Link for attending virtual interview will be shared by participating organisations to all consented candidate at their registered e-mail id.
 - d) Recruiting entity is requested to intimate well in advance (4 days prior to interview) information regarding platform to be used for interview, number of panels taking parallel interviews so as help us in slot allocation and hassle free process on the scheduled date of interview
 - e) CMI&B simply acts as a facilitator to bring the recruiter and NQCA's together
- Roster for the interview will be shared by CMI&B with the participating organization at least one day prior to the interview and available on <https://cmib.icai.org/>.
- The entire process above would be done online on <https://cmib.icai.org/>.

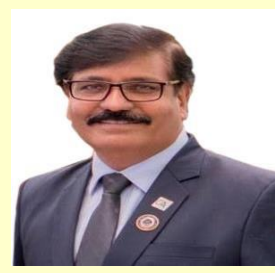
