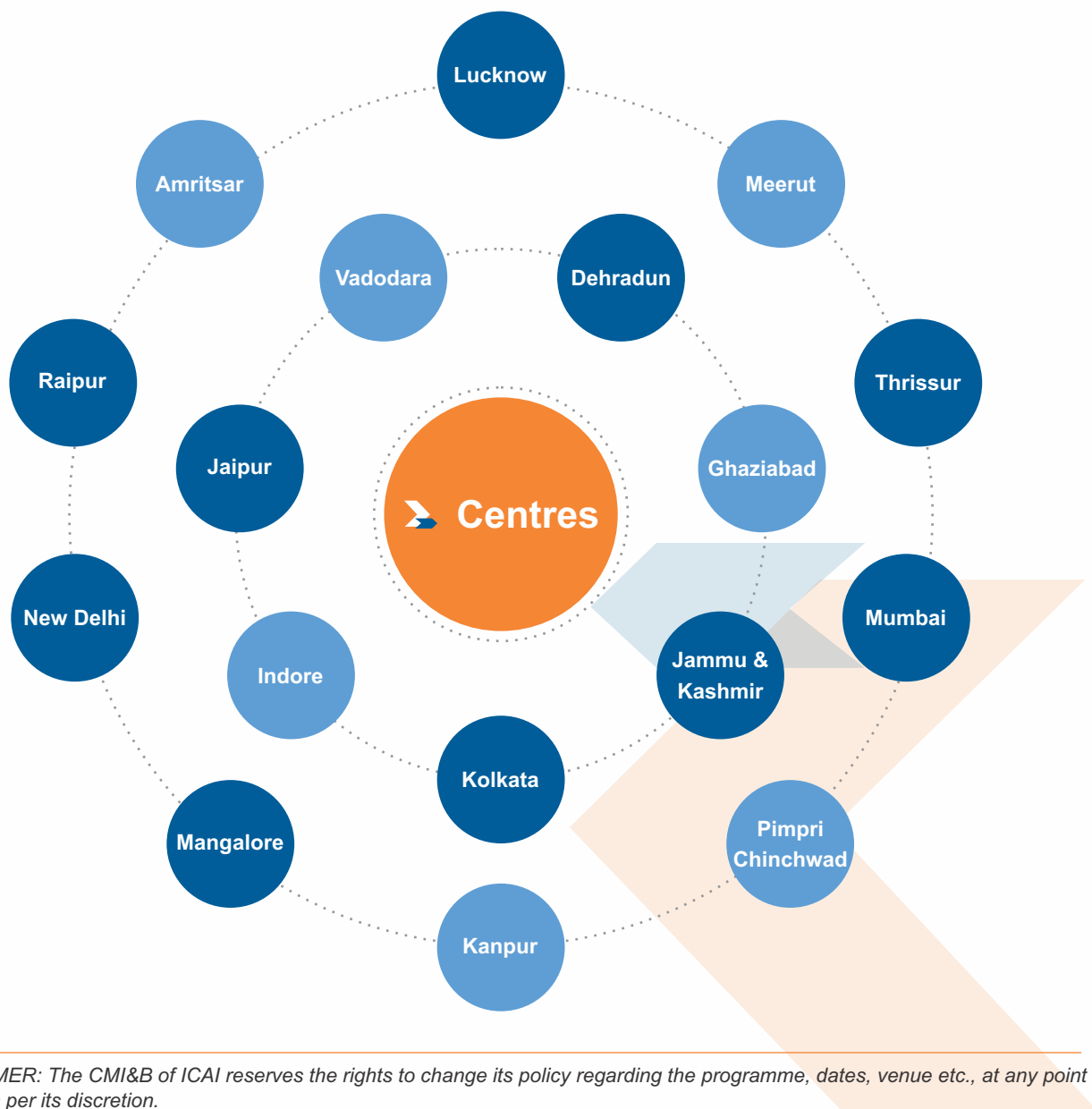
- Online web portal for registration and short listing of candidates

### ➤ Guidelines for the Participating Organisations

- The companies participating will have to register online at <https://cmib.icai.org/> .
- The companies can access the database at <https://cmib.icai.org/>
- Participating companies will have to provide the list of shortlisted candidates online at <https://cmib.icai.org/>
- Final list of candidates appearing for interview will be available online at <https://cmib.icai.org/> one day after consent date by candidate at respective centre.
- Shortlisting of the candidates by the company is restricted to 10 times of the number of vacancies in that particular organization.
- Once a company has selected any candidate and the offer is accepted by the candidate it is the responsibility of the company to inform the Branch heads.
- The companies participating have to offer a minimum CTC of Rs.5.50 lakhs to the candidates in the Second Round of Campus. Day slots will be available on first come first serve basis
- Only one room will be provided to each company for conducting the Interview process.
